# 1. ACCEPTANCE AND VALIDITY:

A Pennsylvania exemption certificate must be used in connection with any exemption under the Pennsylvania Code. For this certificate to be valid, the seller/lessor must exercise good faith in accepting this certificate, which includes: (1) the certificate must be completed properly; (2) the certificate must be in the seller/lessor's possession within sixty days from the date of sale/lease; (3) the certificate does not contain information which is knowingly false; and (4) the item/service is consistent with the exemption to which the customer is entitled. For more information, refer to Regulation 200, Exemption Certificate (Title 61 PA Code §32.2). An invalid certificate may subject the seller/lessor to the tax.

#### 2. REPRODUCTION OF FORM:

This form may be reproduced but must contain the same information as appears on the PA Department of Revenue's form.

#### 3. RETENTION

The seller or lessor must retain this certificate for at least four years from the date of the exempt sale to which the certificate applies. DO NOT RETURN THIS FORM TO THE PA DEPARTMENT OF REVENUE.

### 4. EXEMPT ORGANIZATIONS:

This form may be used in conjunction with form REV-1715, Exempt Organization Declaration of Sales Tax Exemption, when a purchase of \$200 or more is made by an organization which qualifies with the PA Department of Revenue for "Exempt Status". These organizations are assigned an exemption number, the first two digits of this number begin with 75 (example 75-00000-0).
