CARTRIDGE VARIATION Eley .22

Imperial Metal Industries, Ltd., of Birmingham, England, has manufactured ammunition since 1828. Its .22 rimfire match ammunition has won wide acclaim in Olympic and other world-level competitions.

The full line of Eley .22 target cartridges are now imported into the U.S. Five different .22 long rifle match versions are loaded as well as .22 short match cartridges.

The three grades of .22 LR rifle match ammunition all have a nominal velocity of 1085 f.p.s. to minimize wind drift. Tenex, the top grade, is popularly known as "red box" and is the world standard by which other .22 long rifle match ammunition is judged. The American Rifleman Technical Staff uses Eley Tenex for a variety of reference and testing purposes. The nex grade is Eley Match (black box), still a high grade ammunition, but less expensive than "red box." Eley Club is standard grade ammunition, loaded to the same nominal velocity as Tenex and Match for inexpensive practice, hunting small game, etc.

Eley makes two types of .22 long rifle pistol match ammunition. Pistol Match (dark blue box) is loaded to 1000 f.p.s. and is intended especially for ISU free pistol competition. LR Pistol (light blue box) is loaded to somewhat higher velocity, 1030 f.p.s., to provide positive functioning in blowback operated semi-automatic pistols for ISU standard pistol matches. Rapid Fire Match (green box) is .22 short match ammunition for ISU rapid-fire pistol competition.

In addition to low velocity match cartridges, Eley produces two .22 long rifle rounds which have no U.S. counterpart. These are a high velocity match round, and a low velocity hollow-point cartridge. HV Moving Target (gray box) is loaded to 1350 f.p.s. for the fast and mixed speed runs of ISU running game target (running boar) rifle competition. Sub Sonic Hollow Point (olive box) is very popular in England for pest control and small game hunting, combining the positive expansion of a hollow-point bullet with the reduced wind drift, fine accuracy and low noise level of standard velocity ammunition.

An advantage of this load, the

manufacturer says, is that it is less likely to alarm livestock or other pest animals in the vicinity and send them scurrying for cover.

In a brief test by the American Rifleman Technical Staff, Sub Sonic Hollow Point ammunition gave an instrumental velocity at 15 ft. of 1030 f.p.s. in a 26" barrel, and produced fine accuracy in sporting chambered rifles, comparable to Eley Club standard velocity ammunition. The manufacturer advises it may not give reliable functioning of blowback operated semiautomatic rifles, but firing 50 rounds in a Remington Nylon 66 semi-automatic rifle gave only one failure to eject. COMPONENT VARIATION CCI Percussion Caps

CCI has introduced non-corrosive, non-mercuric percussion caps in No. 11 size for blackpowder rifles, pistols, revolvers and shotguns. They feature a soft copper cup of traditional ribbed design, foiled and lacquer sealed for maximum moisture resistance and are said to be ideally suited for blackpowder substitutes such as Pyrodex.

Sierra 170-gr. 7mm Bullet

This 1.235" long round nose soft point bullet is intended for hunting large North American game at moderate ranges. It is strongly constructed and has a 3% antimony core for deep penetration. The tapered gilding metal jacket is cannelured to control expansion and to provide for case crimping.

Ballistic coefficient is given as .277 which is quite good for a round nose bullet. In form it resembles the original 175-gr. round nose bullet on which the 7×57 cartridge built its reputation. Round

nose bullets cannot equal sharp pointed bullets of the same weight in long range performance, but have an advantage in getting through brush because of the higher stability factor. Sierra gives the optimum range of the 170-gr. round nose soft point bullet as from 50 to 250 yds.

Remington Recall

Remington Arms Company, Inc., has announced that under certain unusual circumstances on some of its center-fire bolt-action firearms, the safety selector and trigger could be manipulated in such a way that subsequently moving the selector to the fire position could result in accidental discharge. Remington firearms involved are Model 600, 660 and Mohawk 600 rifles and XP-100 pistols manufactured prior to February, 1975.

The difficulty can be corrected by installation of a new trigger assembly. In view of the

potential safety hazard, Remington is recalling all of these guns produced prior to February, 1975, for inspection and modification as required.

Efforts are being made to contact owners of these guns. Individuals who have Model 600, 660 and Mohawk 600 rifles or XP-100 pistols involved in the recall should write to Remington Arms Company, Inc., Bridgeport, Conn. 06602, or call the following toll-free number for information on procedures: In all states except Georgia -800:241-8444 (ask for Operator 61).
