Please describe your problem: Firing pin is releasing when safety is pushed forward, or sometimes the pin drops when the bolt is closed. How I found out? While I was at the range, this happened and the firearm discharged. As always the muzzle was pointed in a safe direction. It is unsafe to use this weapon and it is dangerous. I would like to take place in the safety modification program and as the representative informed me the firearm will be fully inspected, cleaned and repaired to be a safe functioning firearm.
