

Statement of Unintended Discharge of Remington Model 700 #6787557

On 2 January 2012 after returning to my truck after a morning deer hunt with my daughter, I placed my Remington Model 700, 30.06 rifle #6787557, in my truck at a 45° angle, with the muzzle in the floor of my vehicle. I reached and placed my hand around the stock of the rifle behind the bolt in a normal shooting grip. My finger, or any other object, was not on the trigger or in the trigger guard. As this particular model operates, I had to move the safety lever from safe to fire to open the bolt and render the rifle safe from ammunition. As soon as the lever was moved to the fire position the gun immediately discharged into the floor of my truck. This was a surprise to me and took me back because the first thought I had was "did this rifle just go off?" I immediately asked my daughter if she was okay and I was not injured. Because of the muzzle being in the floor of the truck, it muffled the blast and was not loud.

After verifying no injuries to myself or my daughter, I inspected my truck for damages. I found the entrance and exit in the floor of my truck. Upon further inspection the round severed the gear shift linkage, and entered the transfer case, was ricocheted and exited out. No other damage to my truck was found by me or my mechanic. A copy of repairs is attached also.

I conducted research on the internet after conferring with a friend about the unintended discharge and found many complaints of the Remington Model 700 having malfunctions with the rifle discharging without pulling the trigger and moving the safety lever.

I contacted Dell Fulcher on 3 January 2012 and explained to her what had taken place as written above.
