To Whom It May Concern:

One of our snipers went to shoot his cold bore shot. He loaded the rifle and closed the bolt, as normal. The rifle engaged and the indicator was in position as normal. The sniper squeezed the trigger and there was a slight "click" but it was definitely not the sound of a dry fire. As the sniper raised off of his scope to see what had happen he observed the safety was in the fire position and the bolt was still engaged. The sniper stated he grabbed the bolt handle and the rifle fired. There was nothing on the trigger that could have caused this to occur. The ejected casing did not have any deformities, nor did it appear to have been double tapped. Myself and the snipers have seen the online documents and videos of the Remington 700 rifle having similar problems. Could you also make sure the trigger is at 3.5 pounds? Thank you.
