Dear sir,

Thank you for contacting Remington Arms! The gun absolutely needs to come in for evaluation if it is firing out of battery. As long as you are in the US, we will be glad to assist you with this repair; however, a service request would need to be issued. To do that, we need the serial number off the gun, your name, mailing address and phone number. Once we receive all this information from you, we will send you two emails. The first one will be your actual service request number and instructions, and the second email will follow approximately 24-48 hours later that will have an attachment of a UPS, pre-paid, insured shipping label. You will need to print that attachment and take it either to a UPS hub or hand it to a UPS driver. (The small UPS stores will not handle gun shipments.)

Dear Sir:

I have a model 710, .243 that I traded with my brother-in-law about 5 years ago so I'm not the original owner of this gun. I never new anything about the problem with the gun discharging on releasing the safety. Back in 2011, I was deer hunting and when I released the safety, the gun went off on me. With warm weather gloves on, I thought maybe my finger was inside the trigger guard, so I didn't think nothing of it and blew it off as my mistake. In 2012, my son hunted with the rifle, missing a deer that teed him off severely because when he released the safety, it went off on him. Still not knowing about this problem, I blew it off again thinking he made the mistake of leaving his finger inside the trigger guard. I told him to make sure when you flip the safety off, make sure your finger is no where near the trigger. When that happened, I told a freind of mine what happened to my son not mentioning what happened to me the previous year. He told me about the safety malfunction with the model 710 and said there was a web site to see if this rifle was considered. I found your site and entered my serial number sometime last year and told me that my model was not considered for the recall. Well sir, I used this rifle last weekend, checking it before deer season starts and I made very well sure that I flipped the safety off with no finger near the trigger. The very first round I threw in there went off on me flipping the safety off for the second time on me which makes it 3 times total. I went back to your web site today to enter the serial number again and it told me that this model was not considered for this recall. I want this rifle looked at, and I believe you need to look at a wider range of these models. If I would have never heard of this problem, I would have disregarded this rifle to the side. I would never even think of trading something in so dangerous like this because this rifle in the wrong hands will kill someone. Knowing of this problem, I'm sure there are more rifles like this and you should encourage the original owners to know of this problem. Maybe you have and that is a good thing, but I'm wondering if this trade was made for this reason which.....makes me wonder. My brother-in-law denies this ever happening to him, but I don't care. It's happening to me!!! You need to look at this rifle please. I don't want it recalled...just fix it please.
