Fortunately weapon was pointed at the ground and the weapon discharged harmlessly into the ground. The ficer said he was using his right hand to push the bolt home and was no where near the trigger at he time of discharge. We are requesting a complete examination and repair/adjustment as necessary. Please notify me of the estimated cost prior to performing the needed repairs.

I have talked to another agency in the area and they claim to have suffered a similar event. We are wondering if the weapon should be sent in on a regular basis, perhaps after so many rounds, for a regular adjustment/inspection to prevent this type of accident. Please advise.
