

- CANCELLATIONS:** Orders are not subject to cancellation except with our consent and on terms which will indemnify us for all loss or damage.
 - CLAIMS:** If material supplied is defective or fails to meet specifications, you shall notify us of your claim immediately. No rejections will be allowed unless made within 30 days from the date of shipment, and our liability is limited to the repair or replacement of parts. Under no circumstances shall we be obliged to allow for consequential damages. Estimates of delivery are made by us in good faith but not guaranteed and we do not assume any risk of delay.
 - ADDITIONS TO PRICE:** You are to pay us for any excise, retail, sales or use taxes for which we may be liable. Unless otherwise specified, you are to pay us for all samples requested by you and for idle machine time while awaiting the approval of the samples submitted. Interest of 12% per annum will be charged on all invoices not paid within the specified time.
 - VARIATIONS:** As material herein specified is made to order, we are to be allowed an over-run or under-run on the actual amount ordered of 10% unless otherwise specifically agreed. Since it has been the policy of the metal industry to revise their prices at the time of shipment to us, it may become necessary also to revise our final price accordingly.
 - TOLERANCE:** Unless the purchaser limits all dimensions by specific tolerances, it is understood that commercial tolerances apply. In the absence of a 100% inspection requirement, material supplied shall be deemed acceptable as long as 90% of the same complies with specifications.
