Subject: Market Search for Replacement of the Canadian Ranger Rifle

Dear Sir:

Pursuant to your market search for replacement of the Canadian Ranger Rifle I submit the following information.

Remington Arms Company Inc. is highly interested in this project and is committed to providing the Government of Canada with a suitable weapon system to meet its needs. Upon close examination we have determined that while our existing product line contains items which we feel may meet the needs of the end user we have decided to develop a completely new system to ensure that the end user receives a weapon that exceeds his expectations and will withstand the rigors of the intended environment.

AS I am sure you are aware Remington Firearms Company Inc. is America's oldest most respected firearms manufacturer. In our 191 years of existence Remington has produced well over 5 million 700 based rifles not the least of which are the M24 Sniper Weapons System which remains the current issued bolt action sniper rifle for the US Army and many of our allies. Additionally our action is used by the USMC for the development of their M40 and M40A3 sniper rifles. Model 700 rifles are used every year by tens of thousands of American hunters in every conceivable environment to take game. The model 700 has stood the test of time and remains the hands down favorite for the American hunter and professional alike.

Given this fact we have elected to begin with our Model 700 XCR Compact (Extreme Condition Rifles) which uses a 20" light fluted stainless steel barrel. The barreled action is coated with a Trinyte ® diamond hard finish to withstand extremely harsh conditions. The barreled action is fitted into a graphite composite stock that utilizes an aluminum mounting block for the ease of maintenance, durability and the ability to disassemble and reassemble with minimal loss of sight zero. This rifle will be enhanced to meet the published requirements with components specifically designed for the intended end user and harsh environment it will be used in. We feel that this rifle will provide the best value and capability to the intended end user.



9. BOLT TYPE / LOCKING; 2 lug Remington 700
10. SAFETY MECHANISM; Currently – standard Remington M700 2 position
11. SIGHT TYPE & SCOPE MOUNTS; Ghost right rear, blade front.
12. RAIL FOR OPTICS; One piece Picatinny. Steel Trinyte® coated.
13. BIPOD TYPE; STOCK TYPE & ADJUSTMENT; Harris LM-S adjustment 6-9" or a polymer version.
14. SLING SWIVELS CONNECTION LOCATIONS; 3 sling studs, 1 in the rear 2 in the front
15. MUZZLE BRAKE; None
16. ADDITIONAL REMARKS. This rifle is being designed specifically for this effort. It will encompass components designed for harsh environments and hard use. The sights will be adjustable for elevation and windage for zeroing and will be protected to reduce the possibility of breakage or loss of zero. All metal components will be coated with either Trinyte ® or another similarly durable coating. The current stock is not adjustable however a replacement is being developed to allow for length of pull and cheek adjustment while retaining the durability of the graphite composite and reliability of the 7075T6 aluminum mounting block.
