I know that plaintiff's counsel and Judge Juba have been waiting some time for this material, and I am sorry we could not produce it sooner. The problem was that our house counsel who handles product liability matters has been (and still is) out of state at trial and depositions and on vacation while I myself have been away on other matters. Also, our firearms plant in Ilion, New York, has been shut down for vacation; and much of the requested material is stored in Ilion. Please ask plaintiff's counsel and Judge Juba to bear with us, and we will produce the requested material just as soon as we can by the dates indicated above.

This letter will confirm receipt of your telephone call to our toll-free number regarding the recall of certain Remington Bolt Action rifles and pistols. We would appreciate your checking the following list to verify that your gun is involved:

RECALLED GUNS

All Remington Model 600's

All Remington Model 660's

All Mohawk 600's - except those with a serial number
starting with an "A".

All XP-100's, with a serial number below 7507984, except those
with the prefix "A" or "B" before the numbers.

Remington recommends that prior to any further usage of guns included in the recall, they be inspected - and modified if necessary. If you do not already have the name and address of the nearest Remington recommended gunsmith (who will perform the inspection and modification service free of charge), phone one of the following numbers:

The operator will ask for the model and serial numbers of your gun. Please have both available when you call.

If it is necessary for you to ship your gun to the nearest repair station rather than deliver it in person, do so "COLLECT".
