The first time I shot the gun and tried to load another round the gun fired prematurely. Every time I closed the bolt, even with out a around in the chamber, the firing pen released. I looked at the trigger and there is a set screw that is right by the bolt release and the screw was wobbly so I tightened the screw a little and that fixed the premature firing issue. However, every time you shoot the gun after you lift the bolt the bolt will not open correctly. One has to force the bolt to open. Also the accuracy is very poor. I don't know if the problem I am having contributes to the poor accuracy or not. I have used factory ammo with 250 and 300 grain projectiles. I have 3 other Remington rifles and am very please with all. I hope you can find out what the cause is for the issues I am having with the gun. I intended on using this gun on an elk hunt at the end of October.
