I've faxed a copy of the receipt for the scope I purchased to replace the one damaged in shipment. Total cost, with tax, ended up being \$211.99 which is a bit higher than the \$139 - \$159 range I mentioned in our following exchange. I'm hoping Remington will go ahead with reimbursing the entire amount considering the distance (roughly 500 miles, i.e. two round trips of about 125 miles each way) I had to travel first to take the rifle to Sheels and then to go pick it up after they had checked it out.

Christy:

I've just received a call from the gunsmith at Scheels. While he has yet to test fire the rifle, he wanted to let me know that it checked out OK mechanically. Visible appearance of the stock and scope aside, the only negative comment made was that when the scope was adjusted through the "box test" it didn't return to the exact same point.

Scratches and dings in the finish of the scope and stock were also note but couldn't be confirmed as having occurred during shipment. As I mentioned when we spoke, there were some existing usage marks on the stock, however, the scratches on the scope were not there prior to shipment. Consequently, while I'm happy to hear the scope appears to be functional, I'm not confident about its future reliability.

All things considered, my preference would be for Remington to authorize the replacement of the scope to eliminate my concerns in this regard. Since there is a wide variety of replacement options, it would seem that agreeing to a specific dollar amount that Remington would pay toward purchasing a replacement would be the simplest alternative.

Please let me know what you think.
