In searching for means of logically developing new business, our arms designers have been considering potentials of the handgun market for several years. In this connection it was concluded that chances for success would be considerably greater by introducing a design which might be rather unique and offer advantages not available in competitive models.

In order to reduce investment requirements it was decided that the handgun must be designed for interchangeability of parts and operations with other models. In order to minimize legal restrictions a single shot target and varmint type pistol has been proposed, and a favorable ruling obtained by the Patent Attorney from the U.S. Treasury Department.

The design corresponds generally to the so-called "free" pistols used in International Match competitions. In addition to its use as a target arm, the proposed new pistol would be of great utility to the trapper and to those handling cattle and sheep on open range. Full development of the potentialities of this arm will open up an entirely new field of varmint hunting for woodchuck, fox, coyote and similar animals to the pistol shooter. The effectiveness of the design model was demonstrated in field tests conducted during the past year.

The action is of the turning bolt type similar to some ? of the German target pistols and is provided with a form fitting free pistol type of stock suitable for use for either right or left hand shooters. In addition there is a flare on the bottom of the grip which results in added stabilization during firing. The stock

INTRODUCTION

When the double Derringer was discontinued in the year 1935 Remington ceased production of handguns. Although this model was subsequently copied in West Germany and imported into this country, the handgun business was rather dormant for many years. However, within the last decade there has been a significant increase in sales, with some published estimates indicating volumes in the range of one half million units per year. One of the leaders has been Sturm Ruger, and within the past year they have also moved into direct competition with Remington in the autoloading rifle field.

It is believed that a great deal of their success with handguns has been due to offering them in both the modern and traditional styles, and including larger and more powerful calibers at moderate prices.
