PROPOSED 6.5mm REMINGTON MAGNUM CARTRIDGE AND M/600 RIFLE

)

As requested by the Committee, a preliminary estimate of results expected from development of a 6.5mm magnum cartridge and a version of the M/600 chambered for this caliber has been made. The following summary is submitted, based on data prepared by Marketing and by the Ilion and Bridgeport plants:

III. BASES OF EVALUATIONS

a. M/600 Rifle

Rifle evaluation is based upon estimated volume of 5,000 per year furnished by Marketing, 4,000 of which would be additional business. The remaining 1,000 would come out of sales of M/700 ADL's and other calibers of the M/600.

b. <u>Ammunition</u>

Evaluation is based upon estimated volume of 300,000 per year furnished by Marketing, 100,000 of which would be new business. The balance of 200,000 would come out of sales of other center fire calibers. The proposed retail selling price of \$307.50 per M is the same as that of the 350, 7mm and 264 Magnum cartridges.
