I attended the NRA Exhibition on Saturday, April 3, 1982. My observations and comments about the Remington, competitor, and other exhibits are summarized below. In general, the Exhibition was a very worthwhile experience, providing an opportunity to obtain a good perspective on industry activity and competitive offerings. I recommend that we continue to send representatives from Firearms Research on a rotating basis to permit broad exposure by our personnel.

A. GENERAL COMMENTS

The Exhibition was extremely well attended, indicative of the great interest in shooting sports in the eastern Pennsylvania area. Regarding the exhibits, there were no startling revelations of new firearms or ammunition products. However, the industry was well represented, including all the major firearms, ammunition, handloading components, and optical system manufacturers. While production long guns were clearly a major factor, there was a significant amount of emphasis on handguns, law enforcement shotguns (except for the Remington exhibit), custom guns, limited editions, and etched and plated receivers.

Specific items relating to Remington current and future product development plans are as follows:

Law Enforcement Shotguns

Significant displays of pump action, police riot shotguns were included in exhibits by Smith & Wesson, Ithaca, Mossberg, Savage, and U.S. Repeating Arms. In addition, Benelli displayed an autoloader riot shotgun. I do not recall that Remington had any of our M/870 Riot Guns on display.

Hammer Forged Barrels

Regarding our plans for a new bolt action rifle, Fred Martin has proposed use of a hammer forged barrel, buffed without removing the hammer marks. We have discussed the advantages and disadvantages of this approach and expressed some concern about effect on accuracy. Mannlicher displayed rifles with hammer marks visible the entire length of the barrel. Their representative indicated that all Mannlicher rifles are finished that way.

Hexagonal Receivers

Fred Martin has proposed use of a hexagonal receiver and chamber area on our new bolt action rifle. Several custom gun manufacturers had hexagonal receivers and full length hexagonal barrels on display, including Mannlicher, Wichita Arms, and Shilen Rifles, Inc.

<u>Stainless Steel or Plated Components</u>

A number of our competitors are emphasizing use of stainless steel, chrome plated, or nickel plated components for applications to law enforcement or waterfowl guns. For example, Wichita Arms has a bolt action rifle with 17-4 PH stainless steel barrel, receiver, and bolt and the Mossberg Model 500 Security shotguns offer an optional electrolysis nickel plate on all functioning components.

Waterfowl Shotguns

Smith & Wesson offers special versions of their pump and autoloader 12 Ga., shotguns which feature parkerized finish on receiver and barrel and black oxide finish on bolt and magazine cap for waterfowl hunting.

Detachable Magazines for M/700's

There was a great deal of interest at the Mag-Con, Inc. booth displaying the Kwik-Klip detachable magazine boxes for Remington M/700's.

Injection Molding

The Millett Industries display emphasized their line of injection molded metal sights. Tom Millett indicated that they are still experiencing startup problems with the scope mount line.

Stock Copy Machine_

Don Allen, Inc. exhibited a stock carving machine for small volume production which appears to be ideal for fabrication of research prototypes for field test programs. The machine is a completely manual operation, uses a standard small routing tool (eg. Black & Decker, Craftsman, etc. home routers), and is available in either single or two spindle designs. Don Allen indicated that the machines are available for immediate delivery. Cost is approximately \$10M for the single spindle machine and \$12.5M for the two spindle machine.


