- 3. ADDITIONS TO PRICE: You are to pay us for any excise, retail, sales or use taxes for which we may be liable. Unless otherwise specified, you are to pay us for all samples requested by you and for idle machine time while awaiting the approval of the samples submitted. Interest of 12% per annum will be charged on all invoices not paid within the specified time.
