## FOCUS GROUP - DISCUSSION GUIDE

### WOMEN WHOSE HUSBANDS HUNT BUT THEY DON'T

- Ask each women whether they work outside the home, whether they have any children and what their husbands' occupations are.]
- Has your husband ever asked you to go hunting with him?
