Model 332-Skinner, Orf

OBJECTIVE: Establish a legitimate presence in the Q/U market Production Status:

Communicating with Arms Service-Any New Repairs?

Action: Look at improving efficiencies and cost. (Orf) ACTION: B Orf -M332 Camo-Need to have (2) 26" bbl guns & (2) 28" bbl guns dipped in New Mossy Oak Break-Up and (1) 30" bbl gun in New Shadowgrass by Mid-December 2004. These guns will be displayed in the main meeting room at the SHOT Show to

gauge customer interest.

Three guns returned to Arms Service since last meeting; one gun with bulge in bottom barrel, one with loose fore end and top barrel not firing, third gun was replaced and not fit properly.

Stopped building; will have about 400 guns at year end

### M332 Sporting DL-D Diaz

<u>Need 10K rounds shot through 3 guns to assess durability of design. Need to look at frame treatment.</u> R. Murphy to work with B. Orf on improving design. Must have design complete and finalized by June 1, 2005 for a 2006 Spring Gun introduction.

Current Status

3200 style barrel hanger-Designed barrel hanger set, .040° convergance. Plans to braze 3-5 barrel sets week of 7.21. Barrels will be crowned but not tubed and shot for POI. Side Panels Update

5 prototype barrels with .040" versus .120" converagance built. Will ship to R. Murphy week of 8.23. Not overbored or choked, will shoot for POI/POA. Need to go to a light contour barrel, 28" 30" 32" 34" barrels, tapered rib, stepped rib, straight comb. Current design has bottom barrel 1" higher than top barrel. Need taper of approximately .014" like 3200. Barrels would be straight allowing tube sets to work.

Barrels went together well, less labor

### Model 700 Varmint Accuracy Standards - S. Perniciaro

- We need to establish a protocol to insure that our variant rifles meet a level of accuracy that is congruent with the consumers perception that a variant rifle should be capable of delivering sub-MOA accuracy out of the box.
- We already charge more for these guns, but we can likely get an additional premium if we can guarantee a level of performance.
- We need to firm up our future business of high revenue, high margin products and give the consumer "insurance" in the form of a guarantee that they are justified in paying the premium for a varmint rifle vs. a price point rifle
- We need to control trigger pull weights on the SPL fire control to 3 -3.5 lbs max, guarantee that the rifle shoots MOA or better and include a target in the box with the gun for 2006. Shooting 100% on five different skus; 80% under 1" for three shot groups. Marketing would like to guarantee accuracy in 2006 while going away from HS stock. Will start 2006 varmint run in August of 2005.

### 7400 SGS-New gas system – <u>S. Perniciaro</u>

Sietsema-Tested 30-06 in test lab, 1000 rounds in endurance with 2% overall malfunction rate. Will have 35 Whelan tested by the end of December 80% of tooling will be in place by year end.
