Action: Look at improving efficiencies and cost. (Orf)

ACTION: B Orf -M332 Camo-Need to have (2) 26" bbl guns & (2) 28" bbl guns dipped in New Mossy Oak Break-Up and (1) 30" bbl gun in New Shadowgrass by Mid-December 2004. These guns will be displayed in the main meeting room at the SHOT Show to gauge customer interest.

Bob looking at product coming into ARM. Not a lot of product coming in. All Shoot open cases have been top lever position.

Camo-Colorworks has 2ea 26" and 28" guns and 1ea of the 30". Bob met with Colorworks to review what has to be masked. Colorworks trying to dip a gun semi-assembled. If successful, cost will be fairly competitive. If they have to totally disassemble, pricing will likely be extremely high. 26" in Obsession, 28" in New Break Up, 30" in MAXX-4. Should have samples by end of December. Looking at ways that we could reduce cost on finish from our end (roll engraving, shot blast vs. polish).

M332 Sporting DL-D.Diaz

Need 10K rounds shot through 3 guns to assess durability of design. Need to look at frame treatment. R. Murphy to work with B. Orf on improving design. Must have design complete and finalized by June 1, 2005 for a 2006 Spring Gun introduction.

Current Status

3200 style barrel hanger-Designed barrel hanger set, .040" convergance. Plans to braze 3-5 barrel sets week of 7.21. Barrels will be crowned but not tubed and shot for POI. Side Panels-Update

5 prototype barrels with .040" versus .120" converagance built. Will ship to R. Murphy week of 8.23. Not overbored or choked, will shoot for POI/POA. Need to go to a light contour barrel, 28" 30" 32" 34" barrels, tapered rib, stepped rib, straight comb. Current design has bottom barrel 1" higher than top barrel. Need taper of approximately .014" like 3200. Barrels would be straight allowing tube sets to work.

Barrels went together well, less labor

DAT complete first week of December. T&P-barrels should not be an issue. Biggest issue is raised side panels.

Action: Make sure all future drawings/communications are funneled through Orf. (Diaz/Murphy)

Action: Checkering patterns are an option that need addressed. (Fink) Decision to stay with flat side panels.

Week of 12/6 with new mid-hanger, rib, and muzzle hanger. 11mm-8mm stepped rib. DAT complete beginning of February.

Murphy here today brazing barrel assemblies. Still on track to complete DAT by end of February. Need to know where we are with stock and fore end configurations from Fink (i.e. adjustable, non-adjustable, fore end design, stock design (dimensions), and checkering configuration. Needs to be communicated to Ilion.

M332 20 gauge-2006 New Product Introduction

Current Status-Diaz

Randy assembling parts that were designed by B. Howard; just now resuming work. Murphy assembled parts, but had problems with fitting. Nothing catastrophic, but making changes with Kellems now. Should have parts/bbls by end of month.

M1100 Sporting DL-B. Orf

 Current Status-Make 1100 bbl with 105 ID and choke tubes, .735" with lengthened forcing cones. Goal is to have 10 barrels by September 1st. Boyds should make adjustable comb stock

Target sights

Glass beaded/shot blasted receiver

ACTION: Jeweling bolt-need to investigate bolt cosmetics. Fluting was proposed as an option. B. Orf to look into what is feasible.

Investigating ways to improve surface finish: action bars, slide, action tube, receiver with nickel Teflon finish. Polish hammer, locking block, action spring tube follower, link and hammer plunger with coating. Will have shooting prototypes by the end of September.

Bolt-have not come up with option for jewelling or fluting. Body cote may be an option for the bolt.

Assuming cosmetics finalized by mid September, production could start end of first quarter.

Need-new cosmetics; different receiver look, new for end and checkering pattern ACTION: Fink to supply artistic rendering for benchmark.

NEED competitive review; bring guns to next meeting.

Work with Hogue on grips-Fink to get rendering to Orf to develop.

Orf-Bolt velocities not affected by nickel Teflon finish. Need more rounds on gun then check bolt velocities. Work with G. Sietsema on ways to provide a matte black top radius.

Fink-finalize checkering pattern.

Put additional 100 rounds on guns "break in". Back in lab now for BV's. Proposed finish is a powder coat on top and bottom radius with nickel plate on sides. Where are we on stock and fore end changes – cosmetics, dimensions, adjustability. Need direction on fluting bolt.

Running parts for T&P (with cutdown receiver inserts) through CMM and serializing now. Building into complete guns by 12/22. Will send SN's to E-Town for T&P selection by end of week.

Tool for molded inserts being tweaked now. When final molded parts are complete, will send to E-Town for cursory check.

Enough "old" non-all metal receiver material to last until beginning of March. Will segregate inventory and move through Wal Mart.

Could begin production a week or two after T&P exit.

Model 504-T LS HB - Diaz/Lance/Trull

Need to firm up path forward

Shipping new DAT lot of bbls to Will this week. R&D is going to get correct stock with pillars on them. Trull to call Boyd's to try and get them expedite stocks. 3 guns for SHOT are complete. Outdoorlife's sample is close to complete. Shooting around 0.60" out of jack. Will shoot from shoulder also. Will ship by end of year with M710 all-metal receiver. Lance and Vicars are concerned that a 0.50" max group size is not achievable on a production basis. Plan is to test current batch in DAT and analyze results. Discussion also centered around taking extra care on the heavy barrel models. Suggestions are: lapping all bores, shooting off shoulder and including a target in box with the heavy barrel guns only.

Model 504 Accuracy Standards - Lance/Vicars

- Need to firm up action plan/path forward on guns in OHL
- Need to firm up action plan for production path

Just released 279 guns. Will receive 900 guns back from OHL and begin sorting through, shooting and lapping where necessary. Concern from Lance is time involved. Plan is to monitor open orders and set a target of keeping pace with customer orders plus 5%-10% at any given time.

Current plans on accuracy is focused in on the stock. Have worked with Boyd's to modify the stock to add pillar bedding and to remove the pressure point forward of the receiver (pads at muzzle remain). This has resulted in accuracy improvement of 0.10"-0.20". Cost implications are minimal. Boyd's is to provide 20 sample stocks to validate results and then will implement.

Model 710 Short Action - Diaz

Path forward and status on new direction to use std. action and stock.

Norton working on getting 243 Win barrels made now from outside source. Tooling for Mayfield is 8 weeks out. Will begin EET phase with sourced barrels.
