Thank you for contacting Remington Country. This is a voluntary recall of a limited number of Model 710 firearms. The recall applies only to those Model 710 rifles within the affected serial number range. Only those rifles may have been assembled with an improperly manufactured "Safety Detent Spring." No other Model 710 rifles, and no other Remington firearms of any model, are affected by this recall. We will let you know if yours is included after receiving the serial number.

**700VS vs 700 Police**

Thank you for your interest in Remington firearms. The Police models have a guaranteed MOA. We do not offer specifics for each caliber with different type ammunition. There are too many variances.

The PSS has a tactical stock with bipod swivel, wider fore-end, and larger palm swell. The Police offers a parkerized finish on the metal surfaces. They go through more in-depth and frequent inspections in the production process.

**Rifled barrel using rifled slugs**

Thank you for contacting Remington Country. The fully rifled barrels were designed to shoot sabot slugs. Rifled slugs can be shot through this barrel, however it won't offer the accuracy or distance that the sabot would and you will have a lead build-up in the grooves of the rifling.

#### **11-87/1100 action spring removal**

Thank you for contacting Remington Country. The butt plate or recoil pad can be removed with a phillips head screw driver. Use a long handled flat head screw driver to loosen the action spring tube nut and washers. You would then remove the action spring retaining pin by tapping it out with a punch. CAUTION: the action spring is under tension and will follow after removing this pin.

#### **1100 2 3/4 vs 3"**

Thank you for visiting Remington Country and your continued use of our Remington products. The barrel that is used on the Model 1100 is what determines the size shell that it will cycle. If your barrel is marked 3" only, then it will only eject 3" shells. The Model 1100 was never set up to cycle both size shells.

#### **1100 2 3/4" won't cycle light loads**

Thank you for visiting Remington Country and your continued use of our Remington products. The barrel that is used on the Model 1100 is what determines the size shell that it will cycle. If you have an 1100 field 2 3/4" barrel, it was designed to handle 3 1/4 drams of powder 1 1/8 oz of shot up to 2 3/4" magnum loaded shells. There is not a conversion that will allow it to cycle lighter loads.

#### **Break-in Procedure**

Thank you for contacting Remington Country. Remington does not have a standard break-in procedure. A guideline would be to swab the bore between each shot for the first 20 shots and then every 3-5 for the next 20-40.
