

Bifles manufactured since 1983 were not made with a bolt lock style safety. If your gun has a bolt lock safety, the safety must be in the "F" or fire position for you to open the bolt on the gun. This contrasts to a non-bolt lock firearm where the bolt may be opened with the safety on the "S" or safe position. To determine whether your rifle has a bolt lock safety do the following: Make sure your rifle is completely unloaded no rounds in magazine or chamber Point the muzzle in a safe direction Place the safety in the safe position Close the bolt Try to open the bolt while the safety is still in the "S" position. If your bolt cannot be opened - The gun has a bolt lock safety.
	When did you switch from a bolt lock style safety to standard safety?	In 1982. We switched because the market asked for that feature to be eliminated. We have over the years replaced a persons bolt lock safety with a non-bolt lock safety. We removed the bolt-lock from Model 700 rifles made after 1982 because we perceived that more customers were preferring rifles without bolt- locks. We have, over the years since, replaced a customer's bolt-lock
		safety with a non-bolt lock safety upon request.

	Why would some hunters prefer a bolt lock safety on their gilles?	Some hunters prefer to know that whenever the safety is in the "s" position the bolt cannot be lifted inadvertently thereby preventing the rifle from firing. Others use the bolt-lock safety as a means of checking to make sure the safety is on "S" position. They know that if they cannot raise the bolt, the safety is on. For those reasons the bolt lock safety feature was used on most military bolt-section firearms over the last 50 years. However in recent times, bolt- action shooters expressed a desire for being able to unload the rifle when the safety is in the "S" safe position. To accomplish this the bolt lock had to be removed. Absent that features the firearms perform in the exact same manner

The "tricking" phenomenon referred to in the program has nothing to da with the type of accidental discharge alleged in the Barber incident. Change was made 25 years ago to prevent possibility form happening (The "Trick test" as its name implies involved the deliberate manipulation of the rifle to see if it could be induced to malfunction. The 1% or 20,000 figure referenced an estimate of the number of Model 700's made before 1975 that due to a stack up of manufacturing tolerances could potentially be "tricked". Although we did not believe that "tricking" was a phenomenon likely to occur in the field, in 1975 dimensional changes were made to the internal parts of a Model 700 riles to eliminate the potential of such an event. As a result model 700 made after 1975
		cannot be "tricked".)
