I HAVE PURCHASED SEVERAL
REMINGTON FIREARMS AND I HAVE HAD
GOOD SUCCESS WITH ALL BUT THIS ONE.
I AM VERY DISAPPOINTED WITH THIS RIFLE.
I'VE NOT EVEN SHOT TWO COMPLETE BOXES
OF SHELLS THROUGH IT AND THE GUN,
FOR SOME REASON, MISFIRES. I THINK IT
IS SOMETHING IN THE SAFETY MECHANISM.
I NOTICED THAT ONCE I GOT THE GUN
SHOOTING, THAT IF I LEFT THE SAFETY
ON FIRE, 95 % OF THE TIME, IT WOULD
CONTINUE FIRING. SOMETIMES, EVEN THEN,
THE GUN WOULD NOT FIRE. I CALLED
THE REMINGTON COMPANY AND THEY HAD
ME SEND THE RIFLE TO A SPORTING GOODS
STORE TO HAVE IT REPAIRED. I REPEATED
THE PROBLEM IN A LETTER AND SENT IT
WITH THE RIFLE. FOUR DAYS LATER I RECEIVED
MY RIFLE BACK IN THE MAIL. NO LETTER, NO
PHONE CALL TELLING ME WHAT WAS WRONG
WITH MY GUN AFTER I SPECIFICALLY ASKED
THEM TO. I THEN CALLED THE COMPANY ASKING
THEM WHAT THE PROBLEM WAS. THE MAN AT THE
SPORTING GOODS STORE TOLD ME THAT HE CLEANED
THE BOLT AND THE TRIGGER ASSEMBLY AND SAID
HE TEST SHOT THE GUN 15 TIMES. I THEN
TOOK MY RIFLE OUT TO SIGHT IT IN AND FLIPPED
THE SAFETY BACK AND FORTH TWICE. THE GUN
WOULD NOT GO OFF.
