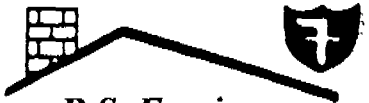

DAMAGE, ETC. Should Purchaser become aware of the damage to Purchaser's property by Contractor his agents, or employees during the course of installation of the roof said damage shall be brought to the attention of the Contractor prior to the time of payment for the roof in question. If the purchaser fails to notify Contractor of said damage within 5 working days of occurrence then Purchaser shall waive all rights against Contractor concerning said damage.
INSURANCE, ETC. Purchaser hereby assigns to Contractor all rights Purchaser has in any Casualty and homeowners Insurance should some be available towards the payment of work performed by contractor not to exceed the amount of this contract price. Said assignment shall not relieve Purchaser of this obligation to pay in full per the terms and conditions of the contract
ACCESS TO WORK. Purchaser grants Contractor full access to entire perimeter of building for staging and execution of work unless otherwise agreed
SUPERVISION AND QUALITY CONTROL. The Contractor shall supervise and direct work, using his best skills and attention. The Contractor shall solely be responsible for all construction means, methods, techniques, sequences and procedures and for contracting and performing all portions of the work and quality control under the contract.
TERMS, ETC. Payment is due upon satisfactory completion. Any portion remaining unpaid will bear interest at the rate 1.5% per month commencing 30 days after completion.
LIEN, ETC. Purchaser hereby grants a lien on the property to secure the payment of all sums payable and to become payable by Contractor
ARBITRATION, ETC. Any controversy or claim arising out of, or relating to this contract, or the breach thereof, shall be settled by arbitrators in accordance with the contractors Industry Arbitrators Rulers of the American Arbitrators Association, and judgement upon the award rendered by the Arbitrator(s) may be entered in any court having jurisdiction thereof.
