Problem with gun:

This gun will shoot when the safety is released. This doesn't happen every time the safety is released, but I never know when it might happen. It took me quite a few times to realize that this was going on because I would think that my finger was on the trigger. Then one afternoon I made sure the gun wasn't loaded and tried it to see if I could reproduce the same situation and the gun will shoot when the safety is released.

I talked with a customer service representative from your company on Thursday, April 17 2008 who advised me to send the gun in immediately for repair.

Bolt is included in the box, but not in the gun.

I tried to get the rings off before I boxed the gun for mailing, but was unable to get the screws loose. Please make sure that if the rings are taken off for any reason that they are sent back when the gun is repaired.
