<p>Please describe your problem:</p> <p>I am returning this rifle for the bolt lock safety modification</p> <p>Also, I request you check the safety and trigger mechanism to correct the following problem:</p> <p>The firing mechanism sometimes will not cock even if the safety is left in the fire position. However, if the safety is engaged while the bolt is back (action is open), the mechanism will cock. When the safety switch is then pushed forward in preparation of firing, the firing mechanism activates immediately.</p> <p>361 characters left</p>

Re: Remington 7mm magnum, model 700 BDL ser# 6313931

I am returning this rifle to you under the bolt-lock safety modification program.

As you can see my 7mm mag has had a lot of use over the years. Recently while at the local range, I noticed that the firing mechanism would not cock when I worked a shell into the chamber.

I learned that the firing mechanism will cock if the safety is switched on while the bolt is back, but not if the safety switch is left in the fire position. However, once the safety is pushed forward to the fire position, the rifle fires immediately without having to touch the trigger.

Fortunately, I did this with no shell in the chamber. I talked to a local gunsmith about it and he said he had heard of a couple of accidents with the 700 possibly arising from this problem. It seems to me to be advisable that customers should be warned about this potential issue if you have seen it in other rifles of this style.

I hope the bolt-lock modification will solve the problem, but I would ask you to look the mechanism over carefully to make sure that the problem is corrected.

Please contact me if there are any questions about repairs needed for this rifle.
