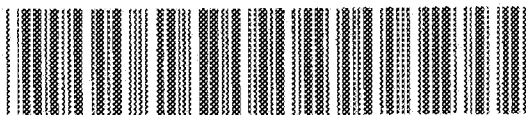

I own a Remington Left Hand Model 700 Serial Number B6775586 in 0.270 caliber.

Yesterday, while at a special 4 day rifle training course (African Safari), I experienced what would appear to be a failure of the Remington safety system. Specifically, while the rifle was being supported by mechanical means, I had my left hand over the bolt knob and using left thumb only pushed the safety knob forward AND THE RIFLE FIRED ON ITS OWN. There were no fingers or otherwise anywhere near the trigger, witnessed by at least one other adult.

What I wish to ascertain is:

1. As I purchased this rifle used, was it subject to a recall and I didn't get the message?
2. Is there some part that I need to know to change out every XXX rounds or whatever?

I am not anti-gun trying to make any type of statement, I want to make this specific Rem 700 and my wife's 700 safe so whomever is in front on a hunt is comfortable, which I/she are not at this 1 day situation later.
