

I have decided to send my Remington Model 700ML back to Remington for repair, replacement or buy-back. I can not locate the receipt where I purchased the rifle back in 1997, but I have purchased a replacement muzzie loader from Cabela's for \$199.99 including shipping. I feel this would be a fair buy-back price for my Model 700ML.

I have had a gunsmith look at the rifle and he will testify that the trigger has not been modified in any way and that the gun looks to have been very well maintained.

The rifle was upgraded several years ago to the 209 shotgun primer. As you probably know, the conversion requires changing parts in the bolt and installing a new breach plug. To make sure this was not causing the issue of firing when taken off safely, I replaced the bolt with one that I borrowed, which had not been upgraded, and the rifle still had the firing issue when taken off safety.

If the decision is made to buy-back the rifle, I would very much like to have the bolt and breach plug that has been upgraded to the 209 primers. The friend that I borrowed the bolt from would like to use it on his Model 700ML.

If this meets with your approval, I will ship the rifle this week. I still have the UPS shipping labels you sent back in November.



I have a Remington Model 700 ML, Serial # ML073779. My trigger has groves which I believe means I have the "Walker Firing Mechanism".

Last Saturday while deer hunting, I found that my rifle will fire when taken off safety without pulling the trigger. I was attempting to shoot a deer when it first happened and did not really realize what happened. Later in the day, I was attempting target shoot with the gun to make sure it was OK. (This is when things got really scary) I loaded my rifle and was preparing to fire....When I moved the Safety Lever forward to the "Fire" position the rifle fired with out touching the trigger. Because my thumb was still on the Safety Lever when the rifle fired, the kick busted the end of my thumb and blood went everywhere.

From information on the Internet, there appears to be a safety issue with Model 700 rifles with the "Walker Firing Mechanism".

Is this true? If it is true, is Remington recalling or replacing the rifles?

I thank my lucky stars that I was the only one hurt and someone didn't get killed. This gun is dangerous.


