When dry firing it later he noticed the click was much louder. He thinks it's about 5-6 years old. He had also sent an email to Remington.com, incid # 101116-000148 stating "I just leveled off on a wild pig and when I squeezed th trigger nothing happened. When I pulled the barrel up and went to use the bolt to unchamber the round as soon as I touched the bolt the gun discharged. I own a Model 700 30.06 serial number c6868962 I was told by a buddy of mine that these guns were dangerous and had trigger problems. I have owned this gun for several years and purchased it new in the box. I have sworn by it and never had a problem. I considered the gun reliable until today when had the gun not been pointed up could have killed me or anyone near me. Please advise on if there is a repair that needs to be made or if I should send the gun in. 

I am sending this because I have had no response as of today. Sunday morning I took aim on a wild boar and squeezed the trigger. Instead of the reassuring "boom" I normally get I instead got a small "click". I pointed the rifle up and just as I touched the bolt to unchamber the round the gun fired in my hands. I had to sit down at that point because it really shook me up. I have owned my rifle for several years and never experienced this before. I have a friend who said "he saw something on the news" regarding this trigger problem Remington has has with the 700. I have always sworn by my Remington rifle and keep it maintained and clean.
