I apologize for the inconvenience that this incident has caused and I hope that these actions will keep you a loyal Remington customer.

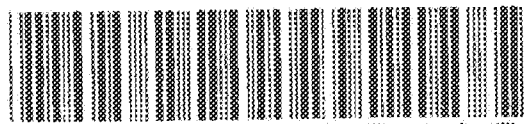
