I hope that this action will keep you a loyal Remington customer.

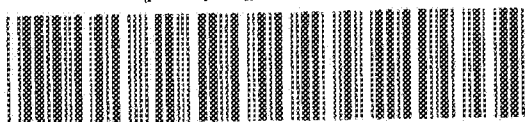
