This rifle (# E6747974) is owned and fielded by the Fairborn Police Department as a scope-sighted precision rifle on a regional tactical team. It has been cleaned and maintained by its assigned user after each use or approximately 20 rounds, (whichever comes first) since being put into service by this agency. Its trigger was inspected by a Remington Armorer at Gander Mountain in Huber Heights Ohio. No defects were found, no excessive debris was reported, and no adjustments were made from factory settings. Trigger pull was measured at 4 lbs. 14 oz.

On May 24<sup>th</sup>, 2011 at approximately 1300hrs this rifle was loaded with Federal 168 Gr. Sierra Match King BTHPs (lot # P21X655) at the Butler County Sheriff's Office outdoor range. After the bolt was closed on a live round, with the safety in "SAFE " position, (which had been set after cleaning the weapon at 1230 hrs) the trigger was pulled. When no round was fired a quick inspection revealed the safety was in the "SAFE" position. Safety was changed to "FIRE" with right index finger. The weapon immediately discharged with nothing touching the trigger. There were two witnesses to this event immediately to the right of the shooter and one standing behind the shooter.

The bolt was run and a new round chambered. The rifle was then unloaded and function checked. It was then subjected to multiple (the count stopped at 100) bolt closures with the safety on "SAFE", a trigger pull, and then safety being switched to "FIRE". There were no additional firing pin releases during this testing. The rifle was then removed from service.

Please check the trigger in this rifle and replace it with a 40x trigger. This weapon will not be returned to service with the existing one. Additionally, since this rifle has been fielded during tactical operations in inclement weather for a number of years and had several thousand rounds fired thru it, please check the bore, headspace, and throat (for erosion).
