FIREARMS - GENERAL CONDITIONS:

The following conditions apply to all those customers whose firearms relate to consignment, trading, gunsmithing or warranty work at Reeds, if a customer does not agree to these terms the customer must not leave the firearm at Reeds:

- Once a firearm enters Reeds, it is regulated by the ATF and other governmental laws. Thus, a FBI background check must be performed even upon the return of the firearm to its original owner, the consignee. In the case of a handgun or AR frame, the recipient, including the owner, must possess a valid handgun permit.
- Use of a firearm is a dangerous activity and any possessor or purchaser assumes the risk of any such use. Consignees, those trading-in firearms, using gunsmithing services or sending in firearms for warranty work agree to indemnify, defend and hold harmless Reeds from any claims, damages, costs or attorneys' fees incurred relating to the possession, display and sale of the firearm.
- Consignments and Trade-Ins. Those consigning or trading-in firearms at Reeds represent and warrant the firearm is in good, safe working order. Firearms found to not be in proper working order will be returned to the owner or repaired at the owner's expense even after the sale of the firearm to another customer. Customer agrees to indemnify, defend and hold harmless Reeds from any claims, damages, costs or attorneys' fees incurred relating to the possession, sale and subsequent use of the firearm. Customer agrees to hold Reeds harmless if the customer's firearm is damaged, stolen, lost or otherwise reduced in value while at Reeds as it is part of the risk of any display and sale of a firearm. Display and payment terms for consignment firearms may change as reasonable from time to time.
- Returns. All guns are sold AS IS. A restocking fee will be charged on all firearms at minimum to cover the costs of processing federally-mandated data records. All warranty matters must be handled directly by customer with the manufacturer.
- Warranty Work. Repair work requested to be covered under warranty. If a customer's firearm is sent in through Reeds for warranty work, the customer agrees as follows: 1) The customer pays all shipping and insurance costs. 2) Only the factory can authorize warranty claims; Reeds staff can only speculate and advise of the likelihood of coverage.
- Gunsmithing Services. Gunsmithing services and repairs are only arranged by Reeds with an outside, independently-owned gunsmith. Reeds facilitates gunsmithing work for its customers as a courtesy. All repairs, claims and issues relating to gunsmithing should be handled directly by the customer with the gunsmith (Walker, John Ahrends: 218-751-3761; Onania, Stu Austing: 320-258-3980). Reeds will make every effort to have your firearm repaired to the highest standards. With the exception of warranty work, repair expenses and any harms, claims or costs relating thereto will be the responsibility of the firearm owner and/or the gunsmith.

- Marlin 308MXLR, (S/N: 91808643) where the receiver and barrel seem to be out of alignment not only on the boresighter, but also to the naked eye. The rifle is impossible to boresight and equally impossible to sight in at the range by the customer. *231545*
