EACH OF THE THREE ROUNDS FIRED WHEN THE SAFETY WAS MOVED FROM SAFE TO FIRE. IT HAS SUBSEQUENTLY DONE THIS ON MULTIPLE OCCASIONS WHEN I DRY FIRED IT TO SEE IF THE PROBLEM WOULD REPEAT ITSELF. THE MESURES WERE WITNESSED BY S.A. DAN WARD, AN FBI SNIPER FROM SALT LAKE CITY. I HAVE SHOT 100-200 rounds through this rifle as currently SET UP w/ NO PREVIOUS PROBLEMS. GUN IS UNLAWFUL w/ CURRENT SAFETY/TRIGGER MECHANISM.</p>

Consumer's Original Complaint :

Remington 700 rifle has a defective trigger that fires when taken off safety. Remington has refused to repair or replace the defective trigger.

I purchased a \$900 Remington 700 CDL Stainless Fluted limited edition .260 Remington rifle. Remington claims that the X-Mark Pro is an adjustable trigger and markets this heavily to sell this gun and trigger configuration. I adjusted the trigger appropriately, it worked fine, was tested according to gunsmithing standards and worked perfectly for approximately 200-300 rounds. The weapon has never been used for hunting and has always been shot from a bench and has been stored in a gun safe. After approximately 200-300 rounds...which is just enough to fully break in a barrel and develop load data for this weapon, the trigger started to stick and would not return. As a result, the weapon would fire automatically when the safety was moved from the safe to fire position. I own over 30 firearms and at least a dozen other Remington weapons. I also use Remington weapons as work and I probably shoot 20,000-30,000 rounds a year through my various weapons. In 40 years of shooting this is the first weapon I have seen with such an unsafe and defective trigger mechanism. I sent the weapon to Remington and they refused to cover the defective trigger and would only repair it for near the price of a new custom trigger that is significantly better in quality.

I questioned Customer Service about all of their advertising claims about the X-Mark Pro being an adjustable trigger as this is one of their big marketing ploys. They immediately backed off their advertising and claimed that it could not be adjusted by the consumer and could only be done by Remington. However, this is not Remington's sales pitch with any of their dealers or advertising materials and is just an excuse to not back up their products. They claimed that if the trigger pull was adjusted, they would not warrant the trigger. Call any Remington dealer in the country and they will tell you the X Mark Pro is an adjustable trigger and none will say it voids the warranty if the consumer adjusts the trigger.

Finally, I had an FBI sniper sitting and shooting next to me and he witnessed the entire incident and he is willing to make a statement about the malfunctioning of the firearm.

Consumer's Desired Resolution:

After spending over \$10,000 on Remington products over the years, I can't believe they wont warrant a \$50 trigger that is clearly defective. All I request is that the trigger unit be replaced and I will even have my gun smith personally place it on the gun. Thanks
