

Back in August of 1974, I purchased a Remington Model 700, 30-06 caliber serial number 6682690 rifle from a local sporting goods store. Until last week, the rifle has operated flawless. I was in the process of sighting in the rifle for the upcoming whitetail deer season. I loaded the rifle and placed the safety on, after aiming the rifle down range, I removed the safety and the rifle discharged. I bolted the empty cartridge out of the rifle and placed the rifle on safety. Once again I aimed the rifle down range, removed the safety and the rifle discharged on its own one more time. At this point in time, I bolted all of the remaining cartridges from the rifle placed the rifle in the carrying case and went home for the day. A few days later, I talked to a local gunsmith about the problem I was having with my rifle. He informed me that I wasn't the only individual having the same problem with the model 700. He also informed me that the Remington Arms Company knows about the problem and is doing nothing about it. He advised me to go home and access the internet and look for a video entitled; "Remington Under Fire", a ten month investigation conducted by CNBC. SHAME ON REMINGTON !!!!!!!!!!!

I need some help in repairing my rifle. Does Remington Arms manufacture a replacement trigger assembly that I can purchase to repair the problem? If not, what are my opinions? I look forward to your response.
