

Sunday March 25 2012 at 4:15 P.M. I had just returned to my truck after hunting groundhogs. I opened my drivers side door with my right hand. With my left hand I raised my Remington 6mm model 700 bolt action rifle with muzzle pointing straight up. I opened the magazine to let cartridges fall into my right hand. I placed the cartridges on the drivers seat. I then tilted the rifle to the right, horizontal with the ground. As I was tilting the gun I used my right index finger to position safety in fire position so I could remove live cartridge from chamber. THE RIFLE FIRED! The bullet entered the dash, went through the glove compartment, through the cab heater core, and into the fan. I have not found where the bullet ended.

After telling a friend of this incident he revealed to me THE FAULT with the Remington Model 700 bolt action rifle. I have been all over the internet reading about this fault with Your rifle. I am wondering how many more Deaths, Injuries, or Accidents your associates can live with. Thank God it was just my truck that took the bullet and not my Wife or my Son or a Friend or any Human Being.

My heart goes out to the people who have lost a loved one because of your rifle. And prayers to the future Victims.

I believe your company is responsible for the repair of my truck. Could you please contact me on this matter and let me know what you are willing to do.
