He mentions an incident in 2002, hunting in NW PA, very cold, he loaded his rifle with 5 new shells and put the safety on. When a doc came by, he pulled up, took the safety off and depressed the trigger and it did not fire. The trigger would not move. He tried to put the safe back on and the lever would not move. He tried it a couple of times. He unloaded and left for the day. He cleaned and put it away for the year.cm

Dear Remington Arms,

I am writing this email in hopes of getting my Remington 700 BDL 30-06 back in proper firing condition and not harming anyone nor myself. I had a recent incident this past hunting season that made me really reflect on how this rifle has performed in the past and what issues it has had. Some very dangerous, luckily no one was injured.

I have a Remington model 700 BDL chambered in 30-06. Serial number B 6630165. I purchased this rifle for hunting back in the 80's. Since then for the most part the rifle has been flawless. I have had three incidents hunting now that are all attributed to the same problem, the gun will fire BY ITSELF at times when a new shell is racked and the bolt closed. Let me explain.

The first incident occurred in 2002 hunting in NW PA. It was very cold that day. I loaded my rifle with 5 shells and put the safety on. (the gun had been fired previously in the year sighting in). After a while a whitetail doe came by, I pulled up, took the safety off and depressed the trigger.... Nothing, the gun acted like it was froze up. The trigger would not move. I tried to put the safe back on and the positioner would not move. I tried this a couple of times. I concluded at the time the rifle was froze up. I unloaded and walked off of the mountain. That was it for that day. No other opportunities arose so the rifle was cleaned and put away for the year. I never looked into the Non-fire event from then on.
