Steven put the rifle on Safe & crossed over a fence, Caden handed the rifle under the fence and the gun discharged & shot Caden in the left leg, calf area. Steven stated that Caden was in the hosp. for 2 wks, had surgery & still has some surgery to go. Steven said the bullet entered between the knee and ankle, destroyed the calf muscle & fibula, shattered the tibia. Caden's mother is Angee Bellmore in Benson, AZ - Steven did not have an address & phone # for her. Caden's father is Brandon Bellmore in Hawaii for the military - Steven did not have a phone # or address for him. Angee & Brandon are going through a divorce. Rifle is at Sheriff's Dept for investigation. df
