

home for exam. df 8/21/13: I spoke with Derek W. & Kris C. Can do a gun exam at a neutral location on Aug. 27 or Aug 28. I called cust. & he is fine with either day. Cust. also stated - "this was a waste of time because I know the rifle malfunctions and Remington should just send me a check for my patio door and my neighbor's AC condenser with a disclaimer and be done with it. The longer I have to deal with this the more likely I am to get a lawyer. I don't know how you can test a gun without using ammunition". I will call the Union Co. Sheriff's Office & see if I can reserve a room to examine the rifle. I will call cust. back w/info & Derek & Kris. df 8/22/13: I called Union Co. S.O. @ 704-283-3789 & left a VM for the Sheriff's Secretary, Jean Hart, to call in ref. to getting a room where we can examine the rifle at the S.O. I emailed Kris C. & Derek W. w/update. Sheriff Cathey called me back & apprvd a room for gun exam on 8/27/13 & I requested the room from 9am - Noon. Sheriff Cathey's # 704-283-3500. Sheriff Cathey pulled his incident report & said the cust. stated he was trying the clear a jammed ammunition rd. & slammed the bolt shut and it went off. I emailed Derek & Kris w/update. Mr. Haidar agreed to the gun exam on 8/27/13 @ 9am at the Sheriff's Office. Customer stated he is not convinced a proper exam can be conducted without using live ammunition & if this process becomes "worrisome for him-it will become worrisome for us". I relayed all info to Derek & Kris. df 8/28/13: Derek Watkins called. Gun exam was completed yesterday. He stated that he would be dealing with the cust. & to provide the cust. w/his contact # if he calls me. df 8/28-29/13: Customer called & left 8 VM's. Mr. Haidar made threats of bodily harm to me by voice mail. df 9/6/13: Mr. Haidar called & left a VM on 9/5/13 @ 5:02pm ET. VM forwarded to Coe, Watkins, Carson, Sprole, Conger, Irving. Mr. Haidar arrested by S.O. for threatening phone call. df 9/9/13: Receipt from certified letter received from post office. Receipt is stamped 9/5/13. df
