My issue is this. I very recently purchased a 597 synthetic stock 22R scope package. The rifle was purchased for my daughter and I to spend time target shooting between hunting seasons rather than to burn the expense of the high powered ammo. I was very disappointed to find the near unavailability of additional 10 round clips to make the shooting day a bit more convenient. There seems to be plenty of aftermarket knock offs but I find it a bit unfriendly to the consumer to not have such a simple accessory available. Frankly, I'm not so sure I shouldn't have saved the money and bought a less expensive single shot. The gun was purchased at a Gander Mountain store here in Erie, PA. who's service is great by the way. They indicated that the earliest they could expect them was 2014...Really??? We will deal with the inconvenience of a single 10 round clip for now, and I understand the ammo demand and am dealing with that like everyone else...but if you're going to build the guns....there should be adequate parts and accessories available. Had I known, and yes, perhaps I did not do all my homework, I would have not likely purchased the rifle.
