To Whom It May Concern:

This rifle is being submitted for inspection and possible repair. The following is an account of what occurred:

This rifle is deployed as a police sniper rifle. The trigger assembly was replaced by a Remington Certified Armorer. The original XMark Pro was replaced with a 40X trigger, which was purchased directly from Remington. Last week, our sniper was training with the rifle in 10 degree weather when the weapon malfunctioned. He pulled the trigger, the gun failed to fire immediately. He lifted his head from the weapon and it fired. This was approximately 3 seconds after the trigger was pulled. He cycled the bolt and the gun immediately fired as soon as the bolt was in battery. This occurred four or five times consecutively. The gun was immediately taken out of action.

I, as the Remington Armorer, was able to replicate this failure. I placed the weapon outside in 15 degree weather and had the same issues. I stripped down the weapon and noticed the trigger assembly was extremely "gummed up" with solvents, oils, etc. This is obviously a maintenance issue and not a manufacturer issue. Once I properly cleaned and oiled the weapon it performed well. However, that being said, I am returning the weapon for inspection by the factory due to the nature in which it is being used.

If the trigger assembly does need to be replaced, it must be replaced with a 40X trigger. If you have any questions regarding this weapon, please feel free to contact me at the above listed number.
