
The rifle in this box is a Remington, Safari Grade, M700, SN A6416630 in .375 H&H. I purchased this rifle new from B&B in Hollywood, CA about 1978. It has been fired about six to 10 times, during which the safety was never engaged and any chambered round was fired. So only empty cartridges were ejected. There is not a scratch, ding, or mar on any part of it except under where the scope base goes where some residual cleaner might have dried.

I read Remington's safety recall regarding the M700 and tested my rifle with snapcaps. Sometimes the firing pin would release upon partially opening the bolt. When that was observed the rifle was put in a safe and tagged with a warning label so no one would attempt to use the rifle. I had a Timney trigger installed at one time to see if that would cure the problem. It didn't. The Timney trigger for the M700 is an excellent trigger, but it did not cure the problem. So, the original trigger was re-installed. The rifle has been stored like this for over 30 years. The rifle absolutely needs to have the work done to make the rifle safe. I don't want this rifle ever to fire unexpectedly with the bolt partially open.

At long last, after retiring, I have the time to arrange to return the rifle to you. I also observe that Remington has built a better trigger, XMARK PRO, for the M700. If the XMark Pro can be installed in my rifle, I would like it to be installed. Kindly let me know the costs.

The rifle is a beautiful rifle. I want it to be safe.
