

I recently was on a hunting trip in northeast Wyoming. While we were on a freinds ranch the day before hunting opened, we decided to sight in our rifles. I put a shell into my Remington 30-06, rested on the bench, sighted the target and flipped off the safety. I was extremely surprised when the rifle fired. There was no harm to anyone but it was a nervous experience. The stock on the same rifle has developed a split near the trigger. Whether these problems are related I do not know.

I own other Remington products and have had good performance with all but this 30-06. I am very disappointed with this particular rifle, and it is dangerous.

I am sending my rifle to you, in hope that you can remedy these problems. Please notify me after assessing this rifle.
