REMOVAL AND ASSEMBLY PROCEDURE FOR RIVETLESS EXTRACTOR

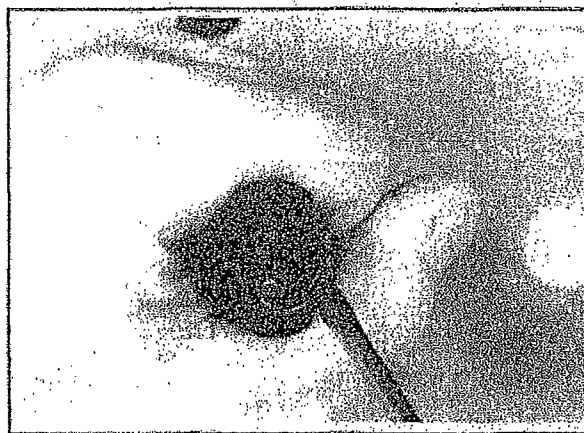
Remington Strongly Recommends Wearing Safety Glasses While Performing Firearms Repairs

NOTE: For ease and consistency of assembly, we find that it may enhance the movement of the extractor, within the bolt face, to lightly stone the top and bottom edges of the extractor body (NOT THE CLAW), before installation.

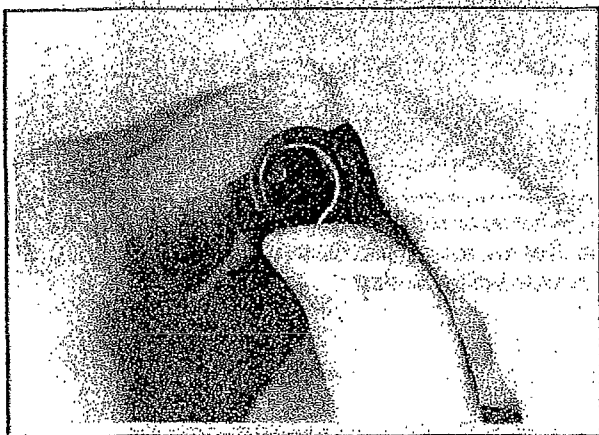
For photographic reasons, one bolt face has been ground to show the extractor in the correctly installed position. The bolt should be removed from the gun and secured in a suitable holding device (padded vise jaw).



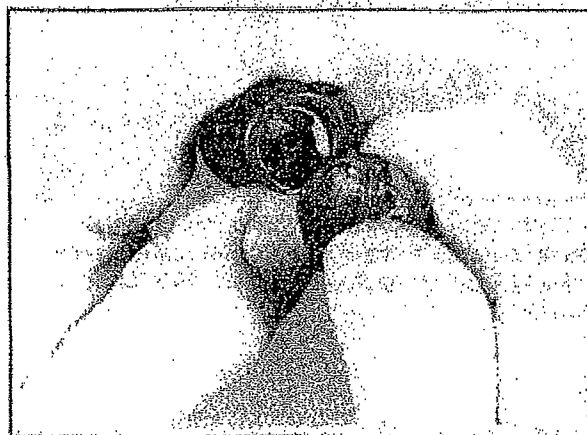
1. With a punch, rotate the old extractor so a thin screwdriver can be inserted along side of it.



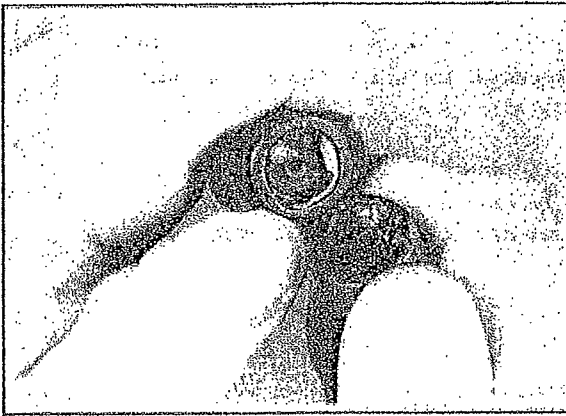
2. Using a thin screwdriver, gently rotate the blade, lifting the extractor from the bolt face.



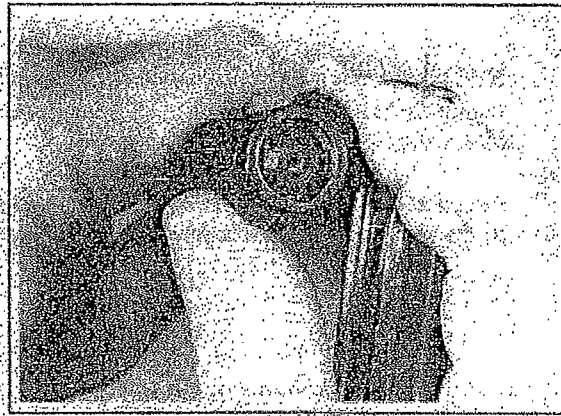
3. Place the tab of the extractor behind the ejector and into the extractor slot.



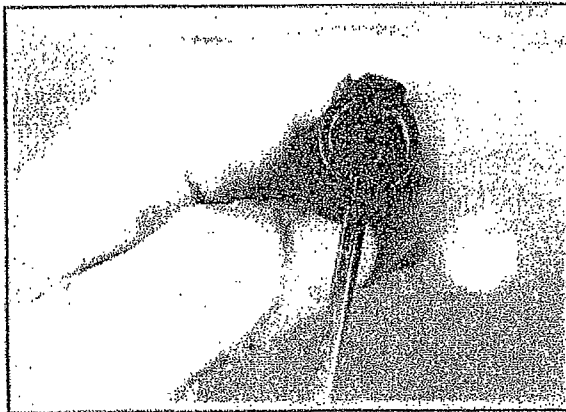
4. With the aid of a wooden dowel or screwdriver handle (plastic), starting at a point midway between the ejector and the extractor claw, slowly work the extractor down and around under the bolt shroud.



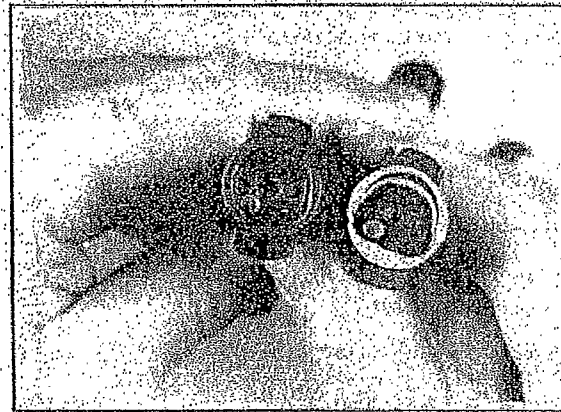
5. Progressively, continue working the extractor around, and under, until the tab end is resting on the face of the bolt. Apply just enough inward pressure on the extractor tab, towards the center of the bolt, until the tab rests in the thumb nail cut in the bolt shroud.



6. Push the tab down until the extractor snaps into place.

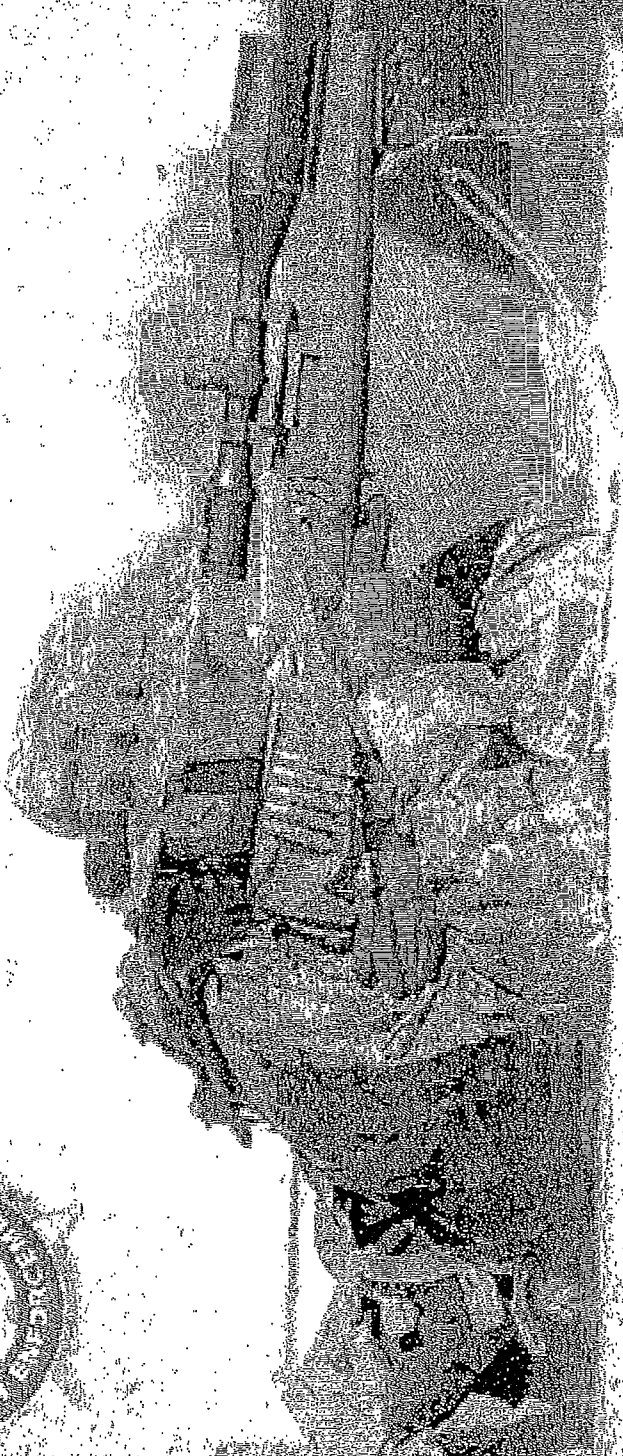


7. Check the extractor tension. Push the extractor claw into the bolt shroud. When released, the extractor should spring back into the correct position and **SHOULD NOT FLOAT!**



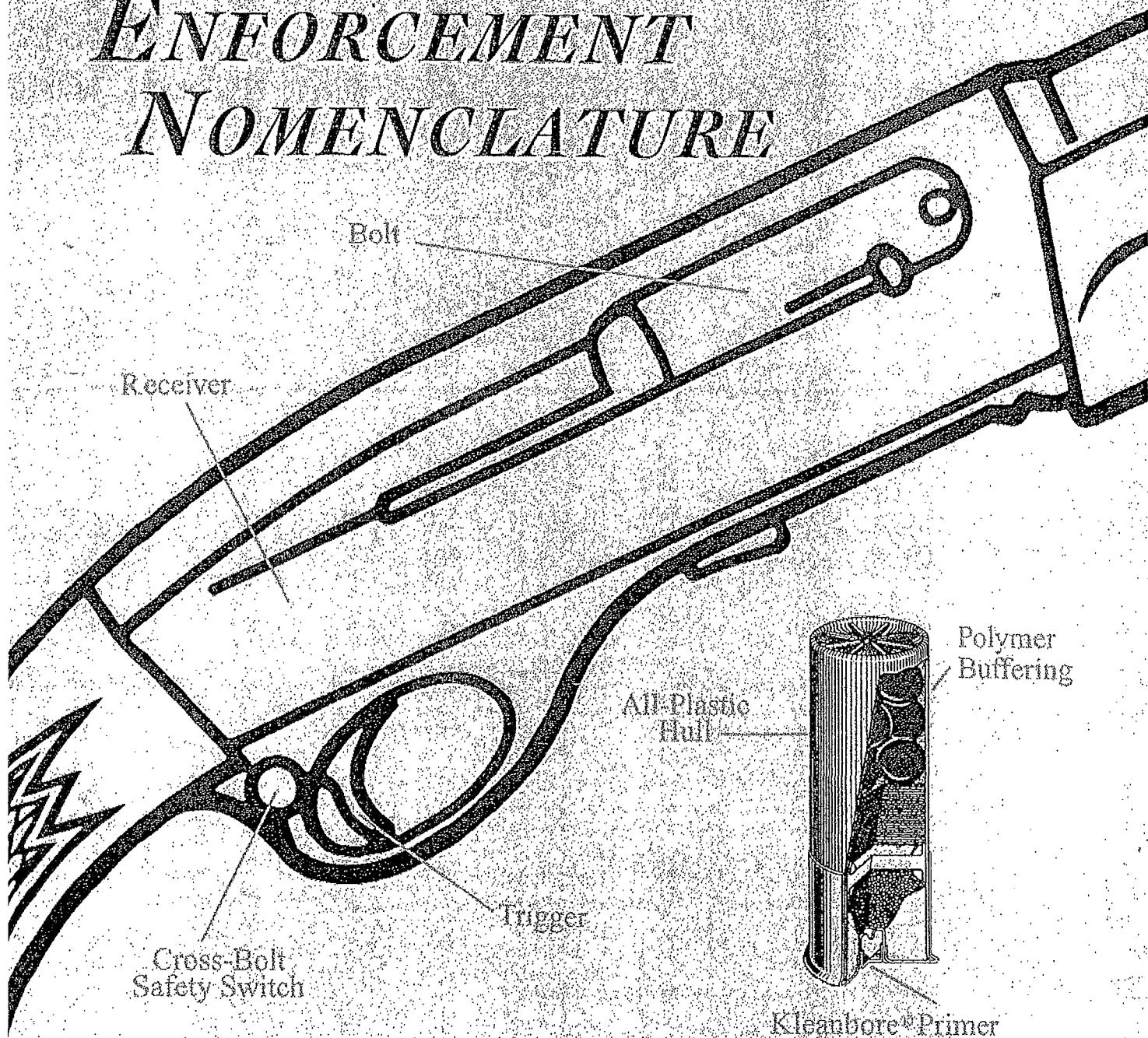
8. A cut-away view of a bolt face, showing a properly installed extractor. Note the location of extractor ends and space behind the claw.
