They have received some of their Model 572 BTs and CWBs and had been doing a good job with them. They still have some stock on hand of the Model CWBs, and it seems that the BTs are selling better for them.

Their ammunition inventory is adequate at the present time; however, they are going to start soon to make their specifications for their first car which will be in April and have requested that Mr. Garrett come down and give them some help with this the early part of next month.
