As per our conversation of 3/23/81, I am enclosing copies of our complete Industrial products catalogue along with pertinent information reference firearms care.

In addition to private labeling for Holland & Holland in London, CRC also sells CRC 3-36 to Ramset Fastening and distributors servicing Smith & Wesson and Winchester Corporation.

Ramset Fastening manufacturers powder actuated tools, and includes a 1 oz. can of CRC 3-36 to be used as both a cleaner and corrosion preventive.

Smith & Wesson currently uses CRC 3-36 as a final coating on their shotguns to prevent corrosion during storage and shipment.

Also, one of the largest firearms dealers in Connecticut recommends CRC 3-36 for use on Remington 870 rifles and model 1100 shotguns, both as a cleaner and corrosion preventative.

CRC 3-36 is well suited to the gun care field due to it's exceptional cleaning ability and it's unique thin film protection.

The rapid fire test results (enclosed) show an actual increase in rate of fire when coated with 3-36, indicating a very thin film, stable film. This thickness varies between .05 and .07 mils.

CRC 3-36 meets the requirements of mil c 23411 - corrosion preventive and mil c-37 B cleaning compound, solvent (for bore of small arms and automatic weapons).

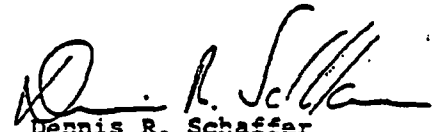
