REPORT TITLE: .375 H & H Model 700 Classic - Custom Gun Shop Pilot Line Test

ABSTRACT

A request was received from L. R. Blackhurst, Custom Gun Shop, to conduct a trial & pilot evaluation of the Model 700 Classic - .375 H & H caliber rifle. These centerfire rifles are being produced in the Custom Gun Shop.

Four rifles (Serial Nos. B6345984, B6344901, B6346044, B6346072) were randomly selected from a warehouse sample lot size of approximately thirty rifles. The evaluation consisted of a visual inspection and field function test.

SCOPE OF TEST

To determine if the sample meets Remington specifications.

TEST RESULTS

There were no objectionable comments on the visual inspection made by C. E. Ritchie (Measurement & Test Lab) and J. H. Hennings (Test Lab). All four rifles shot clean without any malfunctions when subjected to the field function test. (Data sheets for the field function test can be found in Appendix A).
