TEST PROCEDURE:

One hundred rounds of X22LR were shot through the test gun. All malfunctions and breakages were recorded. The gun was then cooled with compressed air. The above procedure was repeated with each ammunition type until all ten types were tested. When all ten ammo types had been tested the tester started over and repeated the cycle until the gun had 3000 rounds on it. At this point the chamber radius was altered by D.S. Findlay and the gun was cleaned. The testing then was resumed until 3990 rounds at which time the Ejector broke.
