SEAR SAFETY CAM RETURN PROCEDURE

LOCATION 52-1

All Remington Safety And Safe Gun Handling Rules Must Be Followed:

1. Plant Receiving will segregate guns received and deliver to Warehouse daily, deliver to 52-1 area as needed.
2. Write up copy of R/E Report, record name and address of customer, attach copy of packing slip (if supplied), record serial numbers on R/E Report if no packing slip with serial numbers is received, issue special R/E number and log in record book.
3. Open five pack using stapler puller, remove staples and discard.
4. Open singles on sand box blue bench, immediately check for the presence of live ammunition, according to plant safety manual section C-14, keep rifle with original box and with other returns covered on R/E Report.
5. Prick punch - Operator to test sear safety cam (PE Tech).
6. If checked OK, re-pack rifle in original box, verify the safety is in the on position and serial number matches end label.
7. If gun failed sear cam check, set aside on designated rack for complete trigger assembly replacement that has been supplied with pre-checked sear safety cam, Arms Service repairmen to replace trigger assembly complete and complete all bench check procedures.
8. Tag (using wire tag) failed trigger assembly, record serial number, date code, and R/E number on special P/E sheet, deliver failed trigger assemblies to D.J. Sanita with complete form. PE to verify hardness.

9. Before box is sealed and prepared for return shipment, all rifles are to have trigger pull measured on sand box repair bench to verify that no outside adjustments have been made, if tampered with, rifle will have a new trigger assembly installed by Arms Service repairmen.
10. After checked and repair has been completed, boxed rifles can be sealed and dotted with a color dot marked SC.
11. Prepare return shipping RE.
12. Larger shipments to be shipped from Warehouse, smaller returns deliver to Arms Service Shipping area.
13. Record shipping date on R/E, complete log with quantity and shipping date.
14. Deliver completed R/E Report to Sheila, Special Services area.
15. Remember these are sold through returns, safe gun handling procedures must be followed.

MODEL 700 PROBLEM

A Small quantity of Model 700, 7 and 40X rifles may have been made with an out of specification part. The sear safety cam in a limited quantity of rifles made between January 10 and March 6 may have been softer than our specification. This "soft" part may show premature wear and may eventually cause harder than normal safety switch forces.

Remington has checked the guns in our inventory and is taking steps to check all guns that were shipped. Teams of employees have been dispatched to the field to check and repair, if necessary, guns at our major accounts. Since the rifles in question were made quite recently, we feel that this will be effective in achieving the repairs of all rifles that may be involved.

PROCEDURE: USE ALL REMINGTON SAFETY AND SAFE GUN HANDLING PROCEDURES

1. OPEN FIVE PACK USING STAPLE PULLER

2. OPEN SINGLES WITH KNIFE AND HAND GUN TO PERSON AT THE PRICK PUNCH OPERATION.

3. PRICK PUNCH OPERATOR IS TO CHECK THE PRELOAD FORCE ON THE CHATILLON GAGE AT THE BEGINNING OF THE SHIFT AND EVERY 50 GUNS THERE AFTER. THE PRELOAD IS TO BE 24 lbs AT THE RELEASE OF THE PUNCH.

IN ADDITION TO THE FORCE GAGE, TAKE THE GUNS WITH KNOWN SOFT SEARS AND PRICK PUNCH THE SEAR. THEN TAKE A KNOWN CONTROL GUN AND APPLY THE PRICK PUNCH. COMPARE THE TWO GUNS TO INSURE THE VARIATION IN DEPTH IS VISUALLY DIFFERENT. ALSO COMPARE THE MARKS FROM THE BEGINNING^{MARK} TO THE CURRENT MARK FOR VARIATION. THIS IS ALSO TO BE CHARTED FOR POSITION AND NUMBER OF GUNS PER INSPECTION. CHARTS WILL BE PROVIDED.

IF ANY MARK LOOKS QUESTIONABLE, SET THE GUN ASIDE AND CHECK THE SEAR WITH THE ROCKWELL TESTER.

4. THE PRICK PUNCH MARKS ARE TO BE CHECKED BY A TECHNICAL PERSON UTILIZING THE 4X ILLUMINATED MAGNIFYING GLASS. THIS PERSON IS TO VERIFY EVERYTHING IN STEP #3. ALTERNATE THIS POSITION EVERY HOUR WITH ANOTHER TECHNICAL PERSON.

5. RECORD THE SERIAL NUMBER AND DATE CODE ALONG WITH THE FINDINGS FOR EVERY GUN.
6. PLACE THE GUN BACK IN THE SAME GUN BOX FROM WHICH IT CAME. VERIFY THE SAFETY IS IN THE ON POSITION AND THE SERIAL NUMBER MATCHES THE BOX END LABEL. RETAPE THE SINGLE BOX AND APPLY A BROWN STICKER TO THE BOX END LABEL. PLACE THE SINGLE BOX BACK IN THE SAME 5 PACK THAT IT WAS ORIGINALLY. IF ANY 5 PACKS ARE SPLIT, SET THEM ASIDE.
7. THE PERSON RECORDING SERIAL #'S MUST VERIFY THE NUMBER WITH THE PERSON PACKING.
8. GUNS DISASSEMBLED AND CHECKED ON THE ROCKWELL TESTER, MUST BE REBUILT AND ALL SAFETY CHECKS PERFORMED BEFORE REPACKING.

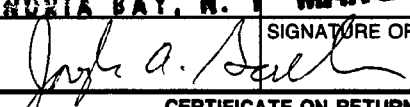
