Mike,

Have you had or heard of any recent issues involving the Remington 700 bolt action rifles. Our team currently has eight counter snipers who are utilizing the Remington 700 Light Tactical Rifles (.308). Last year one of the rifles malfunctioned and fired when the sniper moved the safety lever from the "safe" position to the "fire" position without touching the trigger. We had our second malfunction during training during the month of April 2006 with a second rifle. I know there have been previous investigations into this issue Remington and the company basically related the problems only exist with rifles manufactured prior to 1975. Both of our rifles were purchased in the last five years. The first rifle was returned to Remington who related the problem was corrected and possibly caused by "internal cleaning issues". We are currently weighing our options with the second rifle which has been "grounded" from service. Due you have any in-sight reference to this issue?
