Your Model 700 was produced in 1976. The unloading process for most bolt-action firearms with a bolt-lock mechanism cannot begin unless the manual safety is placed in the F or Off or Fire position. If you participate in the program your firearm will be modified to eliminate the bolt-lock feature and you will be able to unload your firearm while the safety is kept in the S or On Safe position. The operation of your firearm will not otherwise be affected.

Remington is extending through December 31, 2007, its Safety Modification Program to remove the bolt-lock mechanism from certain Remington bolt-action centerfire firearms made prior to March, 1982. (Post-1982 bolt-action firearms were not manufactured with bolt-lock mechanisms). is subject to the safety modification program, click on the model listed below and follow the directions included.

I had this happen for the first time several years ago, but thought it was just an accident, but now it has happened more frequently and I am having trouble with it firing when discharged as well. The pin will dent the cap, but not engage the shell to fire???? Fires when I do not pull the trigger and does not fire when I have a 12 pointer in the scope... Something must be very wrong.
